Subject: Notification to Parents of Teacher Qualifications

As a parent of a student at *Texans Can! Academy at Carrollton/Farmers Branch*, you have the right to know the professional qualifications of the classroom teachers who will teach your child. The Texas Education Agency (TEA) requires the school district to provide you this information. According to the No Child Left Behind Act (2002), P.L. 107-110, Section 9505(2)(B), a highly qualified teacher is one who:

- Has obtained a Bachelor's degree;
- Has demonstrated competency in the subject and assigned to teach;
- Has obtained full State certification as a teacher or has met the State-level standards of examination; and
- Has not had certification or licensure requirements waived on an emergency, temporary, or provisional basis.

You also have the right to know whether non-professional's provide direct, face-to-face, individualized instruction.

It is our policy to inform you of the qualifications of the classroom teachers who will be instructing your child.
